REPORT OF VP's:

Don reported that the ACC Committee is looking for volunteers. Right now it is operating with the assistance of Board Members. Three to Five volunteers would be appreciated.

Pam reported that reimbursements from the County for the upkeep of the front entranceway have been received. On a different note, she mentioned that many vehicles are parking and/or driving on the sides of the road at the entrance, resulting in ruined turf and broken sprinkler heads.

Ideas were floated around to protect that area and Flexi-Guides were suggested by Chris Tulloch. They would be installed at about 8 on each side of the road. Chris would be willing to install and the total cost would be approximately \$800.00.
